Subject: Off Agenda Report Regarding COVID-19 Vaccine Providers Task Force and

**Community Stakeholders Working Group** 

At the Board of Supervisors Meeting on January 12, 2021 (Item No. 15), Supervisor Ellenberg requested an off-agenda report providing a brief summary of the meetings held to date and a membership list for both the COVID-19 Vaccine Providers Task Force and the COVID-19 Vaccine Community Stakeholders Working Group. Last year, the Public Health Department established these two collaborative groups to support efforts in planning for COVID-19 vaccine implementation.

### **COVID-19 Vaccine Providers Task Force**

This task force is composed of representatives from local healthcare systems, hospitals, clinic networks, and county agencies, including Santa Clara Valley Medical Center: Hospitals and Clinics, Stanford Healthcare, Kaiser Permanente, Palo Alto Medical Foundation, the County EMS Agency, various Community Health Center partners, and others. The task force is dedicated to preparing and supporting vaccine providers from major healthcare facilities in the county in administration and management of the COVID-19 vaccines. Topics covered in these meetings include provider enrollment, vaccine allocation, vaccine storage and handling, vaccinator preparedness and training, data management, and other critical vaccine logistics. This group first met in mid-2020 to plan enhanced flu vaccination activities in Santa Clara County. The task force is now concentrated on COVID-19 vaccination planning. Meetings typically include 50 or more attendees. See attached for a roster of task force participants.

### **Vaccine Providers Task Force Meetings:**

- **November 19, 2020 meeting**: This meeting included a discussion of vaccine logistics; a review of federal, state, and local roles; and a discussion and helpful feedback from participants.
- **December 3, 2020 meeting**: This meeting included a prioritization/allocation update, an overview of storage and handling requirements, an update on COVIDReadi, information on the State's PreMod system, and vaccine requirement and provider readiness updates.
- **December 10, 2020 meeting**: This meeting included a prioritization update, an update on the allocation and distribution schedule, a storage and handling update, and new information about provider readiness and reporting requirements.
- **December 17, 2020 meeting**: This meeting included a review of vaccine allocations, transport considerations, other storage and handling updates, provider readiness information, reporting

- requirement updates, and a discussion of other resources.
- **December 24, 2020 meeting:** This meeting included an update on federal prioritization guidance, upcoming allocations, the County's vaccination clinic at the Fairgrounds, an update on extra Pfizer doses, and vaccine provider readiness and reporting requirement updates.
- **December 31, 2020 meeting**: This meeting included a prioritization and allocation update; a discussion of the Phase 1A, Tier 2 & 3 vaccination effort; and storage and handling, provider readiness, and reporting requirement updates.
- **January 7, 2021 meeting**: This meeting included a prioritization and allocation update; an update on the Phase 1A community vaccination efforts; a review of vaccine utilization by healthcare system; and storage and handling, provider readiness, and reporting requirement updates.
- **January 14, 2021 meeting**: This meeting included a prioritization and allocation update; an update on vaccine utilization; and storage and handling, provider readiness, and reporting requirement updates.
- **January 21, 2021 meeting**: This meeting included a prioritization and allocation update; an update on the paused Moderna lot; a discussion of CDPH's revised allocation method; and storage and handling, provider readiness, and reporting requirement updates.
- **January 28, 2021 meeting**: This meeting included a prioritization, utilization, and allocation update; an update on the state's third-party administrator announcement; and storage and handling, provider readiness, and reporting requirement updates.
- **February 4, 2021 meeting**: This meeting included a prioritization and allocation update; discussion of the new "no wrong door" policy; an update on CDPH's changing future allocation method; CDPH's Feb. 3<sup>rd</sup> letter to vaccination providers; and storage and handling, provider readiness, and reporting requirement updates.

### **COVID-19 Vaccine Community Stakeholders Working Group**

The COVID-19 Community Stakeholder Working Group (CSWG) was formed in early December to engage cross sector leaders, agencies, community-based organizations, and other community leaders in the COVID-19 vaccine planning process. The purpose of the working group is to: 1) establish bidirectional and transparent information sharing about local vaccine planning and administration; 2) support the development and dissemination of public messaging regarding vaccine allocation, safety, access, and equity; and 3) advise on efforts to ensure access to COVID-19 vaccines and effective outreach to promote community uptake.

The CSWG consists of 14 diverse working groups representing East San José, South County, the faith community, businesses, the education sector, the non-profit community, the labor movement, disability rights groups, the aging community, the Asian/Pacific Islander community, the African/African Ancestry community, government, and the LGBTQ+ community. Rather than forming a separate Latino subgroup, the working group leads suggested charging each subgroup with identifying strategies to reach Latino residents, given the severely disproportionate impact of COVID-19 on our Latino community. There are nearly 200 individuals currently participating in the CSWG and 40 local leaders head each subgroup. A list of the subgroup co-leads is summarized below, and a list of all participants is attached.

#### **Community Stakeholder Working Group meetings (full group):**

• December 7, 2020 meeting: This meeting included discussion of the COVID-19 surge in Santa

- Clara County, what we know about the COVID-19 vaccines, and the working group purpose and goals.
- **December 21, 2020 meeting**: This meeting included an update on vaccine authorization; a network mapping exercise in breakout groups; and a discussion of the federal vaccine prioritization guidance, the vaccine rollout framework, and the role of working group members and leads.
- **January 11, 2021 meeting**: This meeting included an update on vaccine administration, eligibility, and allocation; a discussion of vaccine program progress and immediate challenges; a review of meeting structure; and subgroup discussion.
- **January 25, 2021 meeting**: This meeting included an overview of vaccine program goals and progress, news from the State, a review of frequently asked questions, an update on County-operated vaccination clinics and language access strategies, and a communications update and feedback discussion.
- **February 8, 2021 meeting**: This meeting included an update on the vaccine program and community-based vaccination sites, state prioritization updates; the County's "no wrong door" policy, the vaccine demographic dashboard, and a discussion of leveraging the work of the subgroups.
